- ⁵ Task 3 in the FY14 scope is funded by the Channel Capcity Advisory Group and is not included in the MAP budget.
- ⁶ Monitoring has been a condition of the short-term Water Rights Orders, and may continue under the long-term orders.
- ⁷ SJRRP submitted a proposal for 50% cost share from the Reclamation Science and Technology (S&T) Program in June 2013. At this time the proposals are still under evaluation. If the proposal is successful, the SJRRP will need to commit 207,500 to match the S&T contribution.
