Summary of Meeting:

Residuals – Tools and Results by Dave Mooney (Reclamation) and Jeff Payne (MWH)

Dave Mooney presented potential tools available to address residual water caused by evolving water supply declarations. Jeff Payne reviewed the assumptions and results of the modeling process used to evaluate the potential magnitude of residuals under various hydrologic conditions.

The group noted the following:

- Residuals are not in the Settlement. Reclamation should prioritize those items that are included in the Settlement and defer any additional effort on residuals.
- The tools presented by Reclamation are acceptable at this time.

Mediation Comments by Dave Mooney (Reclamation)

Dave Mooney provided preliminary comments on the draft "Proposed Implementation Agreement of the Friant Settlement" (draft Implementation Agreement) resulting from the FWUA mediation process. The comments focused on implementation issues of the Mitigation Resources, more specifically, 16(a), 16(b) and Part III, that were identified in the draft Implementation Agreement.

The group noted the following:

• More information is required on transferring water.

16(a) Recapture and Recirculation Update by Dave Mooney (Reclamation)

Dave Mooney informed the group that Reclamation and the FWUA are currently identifying participants for a stakeholder meeting on 16(a) activities. The list will initially include water users, agencies, and the NRDC, but may expand as the process evolves.

RWA Accumulation Method by Dave Mooney (Reclamation) and Jeff Payne (MWH)

Dave Mooney presented additional methods for calculation of the RWA. Jeff Payne provided an overview of the next steps required to implement different RWA methods.

The group noted the following:

Reducing RWA credits because of incidental yield benefits resulting from the
evacuation of storage space in Millerton Lake through Restoration releases is
outside of the Settlement. A conflicting position was offered in response to this
statement.

Public Comment

- Ron Jacobsma requested a status report on the Friant-Kern and Madera Canals Capacity Correction Assessment at the next meeting.
- Peter Vorster noted the compressed meeting schedule and inquired whether future meetings could be extended based on agenda length.
